I know how to distinguish between credible and non-credible sources. I know how to cite information from various sources. I know claims are supported by demonstrating an understanding of the topic. I know reasoning supports or weakens a claim. I know claims are presented in different kinds of writing. <p><i>Reasoning Targets</i></p> <ul style="list-style-type: none"> I can determine which reasons further an argument, not simply restate it. I can determine which technique or supportive format best enhances a claim. I can determine if a source is accurate and credible to support a claim.

Vertical Progression

W.K.1 - Use a combination of drawing, dictating, and writing to compose opinion pieces in which they tell a reader the topic or the name of the book they are writing about and state an opinion or preference about the topic or book (e.g., My favorite book is...).

W.1.1 - Write opinion pieces in which they introduce the topic or name the book they are writing about, state an opinion, supply a reason for the opinion, and provide some sense of closure.

W.2.1 - Write opinion pieces in which they introduce the topic or book they are writing about, state an opinion, supply reasons that support the opinion, use linking words (e.g., because, and, also) to connect opinion and reasons, and provide a concluding statement or section.

W.3.1 - Write opinion pieces on topics or texts, supporting a point of view with reasons.

W.4.1 - Write opinion pieces on topics or texts, supporting a point of view with reasons and information.

W.5.1 - Write opinion pieces on topics or texts, supporting a point of view with reasons and information.
